The photographic services described above represent the full extent of services to be provided. No other agreement exists between the photographer and the client.

A deposit/retainer of \$250.00 is required to book the wedding date. A deposit of 50% of the remaining balance (\$) is due at least 30 days before the date of the wedding and the remaining balance (\$) is due on or before the wedding date. Photography services will not be rendered prior to payment of the full balance described in this agreement. If the client cancels more than 120 days before the wedding date, a cancellation fee in the amount of \$150.00 will be withheld from deposits paid. Cancellations within 120 days of the wedding date will result in no refund of any deposits paid.

Any photo print or album allowances provided with this package must be used in full within 6 months of the wedding date. Any unused allowances will be liquidated at that time and your digital images may no longer be available.

The photo CD that is included with the wedding package is free from any copyright restrictions, and the images contained within may be reproduced without the consent of the photographer. The photographer retains the right to use images from the wedding event for display and/or advertising purposes.

Extreme care and precautions will be taken for the proper composition, exposure, capture, processing, storage, and delivery of the photographs. However, in the event the photographer fails to comply for any reason with the terms of this agreement or if any dispute may arise between the photographer and the client concerning any aspect of the photographic services provided, the photographer's liability is limited to a full refund of deposits and payments made by the client.
